5. FIRE FIGHTING MEASURES

5.1 Extinguishing media

Combustible. May evolve toxic gases (carbon/ nitrogen oxides, hydrocarbons) when heated to decomposition. Finely divided dust may form explosive mixtures with air. May evolve sodium oxides when heated to decomposition.

Evacuate area and contact emergency services. Toxic gases may be evolved in a fire situation. Remain upwind and notify those downwind of hazard. Wear full protective equipment including Self Contained Breathing Apparatus (SCBA) when combating fire. Use waterfog to cool intact containers and nearby storage areas.
